Your personal data will be processed during your application process in response to a specific job advertisement or a speculative application.

Your personal data includes your first and last name, address, date of birth, gender, nationality, denomination, health data, cover letter, photo, curriculum vitae (including details of your personal, educational and professional background), references, certificates, evidence and all contact details at which we can reach you.

It is not possible to process an application without processing your personal data.

The legal basis for this type of data processing is in particular Art. 6 para. 1 a), b), c), e) EU Data Protection Basic Regulation (DSGVO).

Processing on the basis of legitimate interests is only carried out in the case of Art. 6 para. 1 f) DSGVO.

The processing of your personal data for specific purposes (e.g. obtaining references from previous employers or the use of your data for subsequent vacancies) is based on your consent.

Data exchange with service providers and other recipients

In order to fulfill our contractual and legal obligations, we use external service providers, such as a tax consulting firm, lawyers, software development companies, to whom we transfer your personal data if necessary.

In addition, we or the aforementioned service providers may transfer your personal data to other recipients, such as authorities to fulfill legal notification obligations (e.g. tax authorities).

Duration of data storage

We process and store your data in principle for the duration of your application. This also includes the initiation of a contract (pre-contractual legal relationship).

In addition, we are subject to various storage and documentation obligations arising from the German Commercial Code (HGB) and the German Fiscal Code (AO), among others. The periods of retention or documentation stipulated there are up to ten years beyond the end of the contractual relationship or the pre-contractual legal relationship.

Your application documents will be returned in original after three months if you are not hired. Electronic data will be deleted accordingly after three months.
